Functions and The garment offers limited protection against mechanical risks arising from impact and performance levels: abrasion in case of a fall while participating in motorcycling activities.

This PPE item has reached the following performance:

Class A (*): Class A garments offer a minimum necessary degree of protection from impact and abrasion and are expected to have the least ergonomic and weight penalties.

(*): The Standard provides different classes of protection for garm<mark>ents incl</mark>uding protectors/shells: AAA (highest class), AA (middle class) and A (lowest class); class B is for garments not including protectors / shells = just abrasion protection; class C is for impact protector ensemble garments.

NOTES: the protection provided also depends on the correct fit of the garment; the CE-Certified incorporated impact protectors provide strengthened protection and must be kept in their place: this falls within the responsibility of the user.

printed on stitched labels including, in combination, the following information required by the Norm:

- CE Marking;
- brand and name of the Manufacturer;
- PPE item unambiguous designation;
- pictogram indicating intended use (motorcycling) + nr/year of the Technical Draft of reference + indication of the class of protection achieved;
- pictogram "i in the booklet" inviting the final user to read the User Manual;
- on other different labels: "Made in...", composition materials, size label, care and washing instructions etc.
