internal side: black four-sided elastic fabric matched internally with transparent membrane (1030500014); black 228T Taslan (1150129001); white/grey/green fabric (1150200006) and black mesh (1100600006);

mid-layer: transparent membrane coupled with black knitting (1120104001);

removable lining: black 210T Polyester fabric (without coating) (1070210001); black 210T Polyester fabric with LS2 logo (without coating) (1070410006); white wadding (1080400003); black mesh (1100200005) fixed to the jacket by means of red plastic zipper with black metallic slider (302033134511200) in direct contact with the user;
