Functions and  
performance levels:

The garment offers limited protection against mechanical risks arising from impact and abrasion in case of a fall while participating in motorcycling activities.

This PPE item has reached the following performance:

**Class A(\*)**: Class A garments offer a minimum necessary degree of protection from impact and abrasion and are expected to have the least ergonomic and weight penalties.

(\*) The Standard provides different classes of protection for garments including protectors/shells: AAA (highest class), AA (middle class) and A (lowest class); class B is for garments not including protectors / shells = just abrasion protection; class C is for impact protector ensemble garments.

NOTES: the protection provided also depends on the correct fit of the garment; the CE-Certified incorporated impact protectors provide strengthened protection and must be kept in their place; this falls within the responsibility of the user.

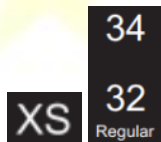
