collar: black microfiber (205018) coupled with grey foam material (511009), black/grey fabric (407003) and grey foam material (511009);

eyelet lining: black coated material (202011);

vamp lining: black/white knitting coupled with grey foam material (410001);

quarter lining: black three-dimensional fabric (405027);

insole: black polymeric material (606008) coupled with vamp and quarter lining in

contact with the user;
