<u>palm side</u>: black grain leather "Goatskin" (Goat-blk) matched with black knitting "Bemberg with glue" (KR Bemberg-Glue); black knitting fleece coated with black polymeric material "Conductive PU" (Conductive-blk) matched with black knitting "Bemberg with glue" (KR Bemberg-Glue);

back side: black grain leather "Goatskin" (Goat-blk); black perforated grain leather "Perforated Goatskin" (Goat-blk-perforated); black grain leather "Goatskin" (Goat-blk) sewn with white foam material and white knitting "Tricot" (Tricot-wht);

<u>lining back side and back side of the cuff</u>: black knitted fleece matched with grey foam material "2mm foam+Bemberg" (Bemberg-foam);

side wall of index and little finger: black grain leather "Goatskin" (Goat-blk);

partial reinforcements: black grain leather "Goatskin" (Goat-blk);


